Terms and Conditions for recruitment of contractual Medical Teaching Faculty at North DMC Medical College, Delhi

2. The contractual salary will be the 1st Cell of the Pay Matrix Level applicable as per 7th CPC.

Please check the official website for any change/update in the schedule etc. As no other type of communication will be sent. Reservation of posts will be as per GNCTD Rules.
4. The experience gained in a Medical College not recognized by the NMC (National Medical Commission) will not be counted towards teaching experience.
