The rates should be valid for six months from the date of opening of this quotation.

Full specification of each item must be given while quoting rates & supported by samples . Exact amount of central excise, packing &

forwarding charges, GST (Taxes) etc may be mentioned separately.

Supply is to be arranged by the firm within stipulated period of 07 days. If delay then penalty of 2% of the cost of orders per week, maximum 6% will be imposed on the firm.
